The applicant shall provide photo Identification (i.e., Driver's license, military I.D., etc.); a copy shall be retained by the City.

Provide a list of items to be sold at the stand for the duration of its operation.

Submit a nonrefundable license fee of \$500.

**NOTE: Per Georgia Code Section 25-10-5.1, signage must be posted at the stand per the following standards:**

(1) Every licensed distributor selling consumer fireworks pursuant to this Code section shall have within the retail display area for consumer fireworks at least one sign providing the following information:

- (A) **“PLEASE CHECK YOUR LOCAL ORDINANCES PRIOR TO USING OR IGNITING CONSUMER FIREWORKS”;**
- (B) **“PLEASE USE CONSUMER FIREWORKS IN ACCORDANCE WITH THEIR AFFIXED CAUTION AND WARNING LABELS”;** and
- (C) **“PLEASE BE A GOOD NEIGHBOR AND BE MINDFUL THAT UNANNOUNCED IGNITION NEAR SOME MILITARY VETERANS AND OTHER PERSONS AND NEAR SOME PETS CAN BE TRAUMATIC”.**

(2) Such signs shall be at least 22 inches by 28 inches in size, be printed in at least 40 point boldface type in a color contrasting from such sign’s background color, and kept free from obstruction and in plain sight of customers.

**NOTE: Georgia Code section 16-10-71 provides that a person who makes a lawful oath or affirmation or who executes a document knowing that it purports to be acknowledgment of a lawful oath or affirmation commits the offense of false swearing when, in any matter or thing other than a judicial proceeding, he knowingly and willfully makes a false statement.**
